# The Truth about Naju

In the era between the 18th and 19th centuries, England's industrial revolution served as a momentum making highly developed and marvelous innovations in techniques that led us to a materialistic civilization. In proportion to this, sins in the world have been growing exponentially when people are headed towards decadence and the way to ruin. The Blessed Mother who wants even one soul to be saved has implored with tears at many places in the world in the 19th and 20th centries.

The Blessed Mother also manifested Herself shedding tears through Her statue which belongs to Julia Kim in Naju, Korea on June 30, 1985. Our Lady of Naju exuded and continues to exude Fragrant Oil which represents Her presence, love, and friendship for the conversion of Her children in the world. Furthermore, Our Lord conferred on Naju 33 Eucharistic Miracles from 1988 to show how important the apparition of the Blessed Mother in Naju is.

Our Lady of Naju emphasized the primary importance of the messages of love over those miracles and signs. The core messages of love from Our Lady of Naju are leading souls to Heaven as it is a practice of the life of resurrection through repentance and amendment of life. In reality, a number of pilgrims, both domestic and from overseas have been spiritually and physically healed and led the life of resurrection.

In spite of the fact that Our Lord and the Blessed Mother of Naju have shown such numerous signs and miracles without ceasing, the Archdiocese of Gwangju, the patriarchate did not conduct any substantive investigations about the loaded fruits of graces as well as the Eucharistic Miracle that St. Pope John Paul II personally witnessed through Julia Kim. The Archdiocese of Gwangju discredits Our Lady of Naju's signs and miracles as heretical. Thus, we want to reveal the truth.

# Reactions from the Vatican and the Archdiocese of Gwangju on the miracles

Archbishop Giovanni Bulaitis, the Apostolic Nuncio to Korea, wrote a report to the Holy See on the Miraculous Descent of the Eucharist that he wit-




nessed on November 24, 1994 during his official visit to Naju as the official representative of the Holy Father.

This prompted the Archdiocese of Gwangju to organize the Naju Investigation Committee. It had its first meeting on January 9, 1995. The Committee hardly conducted a thorough investigation on the phenomena in Naju, and chose to publicize a negative report on June 16 in 5 months proclaiming that all pilgrims should be prohibited from visiting Naju. On the other hand, Pope John Paul II sent his personal secretary Mgr. Vincent Thu to Naju in September 18, 1995 to invite Julia to visit the Vatican.

However, the Archdiocese of Gwangju continues to condemn Naju by issuing a Declaration on January 1, 1998 that the alleged Eucharistic Miracle in Naju violated Church Teaching that the species of bread and wine of the Eucharist must remain unchanged even after the consecration, that tantamount to a denial that all the Eucharistic Miracles including those already approved by the Church.

According to the logic of the Declaration issued by the Gwangju Archdiocese, even Pope Urban IV who accepted the Eucharistic Miracle of Bolsena and established the Feast of Corpus Christi in 1264 and ordered St. Thomas Aquinas to write the Eucharistic hymn (Adoro te devote) should be treated as heresy. Is this the right Teaching of the Church indeed?





The Miracle that the Eucharist changed into flesh(left) and blood(right) in Lanciano, Italy. According to the Declaration by the Gwangju Archdiocese, this miracle approved already by the Church should have violated the Teaching of the Church as well.

On this matter, St. Thomas Aquinas, the Council of Trent, and Canon Law provide the following teachings:

Third Part (TP) of the Summa Theologica Question. 76 OF THE WAY IN WHICH CHRIST IS IN THIS SACRAMENT (EIGHT ARTICLES) Article. 8 Whether Christ's body is truly there when flesh or a child appears miraculously in this sacrament? Consequently, it remains to be said, that, while the dimensions remain the same as before, there is a miraculous change wrought in the other accidents, such as shape, color, and the rest, so that flesh, or blood, or a child, is seen. And, as was said already, this is not deception, because it is done "to represent the truth," namely, to show by this miraculous apparition that Christ's body and blood are truly in this sacrament.

The original document of the first declaration issued by the Gwangju Archdiocese on January 1, 1998, condemned Naju and formed the basis for subsequent negative declarations. It stated that the Eucharistic Miracle, where the Eucharist changed into visible flesh and blood, contradicted Catholic doctrine according to the Council of Trent, DS 1652. However, the Council of Trent, DS 1652, states:

- "If anyone says that in the sacred and, holy sacrament of the Eucharist the substance of the bread and wine remains conjointly with the body and blood of our Lord Jesus Christ, and denies that wonderful and singular change of the whole substance of the bread into the body and the whole substance of the wine into the blood, the appearances only of bread and wine remaining, which change the Catholic Church most aptly calls transubstantiation, let him be anathema." (Council of Trent, DS 1652)
- When the clergy insist on erroneous doctrines, they are automatically excommunicated (cf. Can. #1364(1) & #1336(1)).

So, are Naju pilgrims excommunicated? Or is it the clergy of the Gwangju Archdiocesan Investigative Committee, who denied Eucharistic miracles worldwide, that are excommunicated? • The claim of the Naju Investigation Committee of the Archdiocese of Gwangju stated that it conducted scientific approaches with careful studies and deeply based observations, as well as considerations in faith and phenomenal verification process with field surveys for 3 years.

# ■ The Second and Third Declaration and Decree from the Archdiocese of Gwangju

After the announcement of the First Declaration from the Archdiocese of Gwangju, domestic and overseas theologians and laypeople pointed out the faults of the declaration accurately. They also urged the Archdiocese of Gwangju to correct the distorted Eucharist doctrine. The Eucharist doctrine is the most important one along with the Resurrection of Jesus in the Catholic Church, but Archbishop Andrew Choi of Gwangju persisted his stand when he announced the second Declaration in May 2001 and the third in May 2005. In December 2007, the Vatican asked Archbishop Choi and the Bishops from Korea why they did not proceed with the approval of the Naju signs and miracles and urged them to do so. Homecoming Archbishop Andrew Choi seemed to be flexible on Naju but, announced the Decree on January 21, 2008.

## ■ Fr. Aloysius Chang, face-to-face talks with the Prefect of the Congregation for the Evangelization of Peoples

Fr. Aloysius Chang immediately wrote a petition to the Archbishop Choi to remove 'the faulted Decree' and 'unjust sanctions (the penalty of excardination) to him' but was refused by the Archbishop. Fr. Aloysius Chang appealed to the Holy See and Cardinal Ivan Dias, the Prefect of the Congregation for the Evangelization of Peoples and had a time for face-to-face talk with him.

■ Cardinal Ivan Dias, the Prefect of the Congregation for the Evangelization of Peoples sent an official letter to the Gwangju Archbishop

"As what has been happening in Naju is considered a private revelation, the restrictions do not apply to the pilgrims to Naju. Likewise,



the penalties on Fr. Aloysius Chang should be lifted. Fr. Chang can celebrate Mass."

"Cardinal Dias immediately sent an official letter as above to the Bishops in Korea and the Archdiocese of Gwangju. On this, the Archdiocese of Gwangju insisted that Naju should be supervised by the Congregation for the Doctrine of the Faith (the CDF). After negotiation, the Vatican decided to investigate formally regarding Naju by the CDF. The CDF sent an official letter to the Archdiocese of Gwangju on April 24, 2008.

The main contents were as mentioned earlier that Naju, Non Constat de Supernaturalitate, translated as: Naju, Not confirmed that it's supernatural (under the investigation). Thereupon, Archbishop Choi visited the chapel of Naju on July 2, 2008, and came closer to pilgrims with big smile saying, "I have not prohibited prayers," and "Receive abundant graces from the Holy Spirit." Nobody there was excommunicated automatically by the Decree of Archbishop Choi.

# Three formal announcements about apparition from the Vatican

- 1. Constat de supernaturalitate : confirmed as supernatural. Fatima, Lourdes, Akita in Japan, etc.
- 2. Constat de non supernaturalitate : confirmed as not supernatural (heresy). Bayside
- 3. Non constat de supernaturalitate : not confirmed as supernatural (under the investigation, to temporarily suspended judgment) Naju

# Disclosed official position of the Vatican on Naju

The Archdiocese of Gwangju published its First Declaration regarding Naju as heresy by altering the meaning of "Non Constat de supernaturalitate" (not confirmed as supernatural) concerning Naju Events, consulting with the Vatican, to make it seem like a condemnation, "Constat de non supernaturalitate." (confirmed as not supernatural). Pilgrims who had received graces through their visits to Naju continued their pilgrimages, leading the Archdiocese of Gwangju to issue second and third Declarations, culminating in a formal Decree in January 2008.

Despite this, the issue of Naju persisted. Subsequently, the Archdiocese of Gwangju published a translated version of a letter (NO.112/1993-27066) from the secretary of the Congregation for the Doctrine of the Faith on April 24, 2008, attempting to provide more evidence to condemn Naju. However, that letter did not condemn Naju but reiterated the status of "Non Constat de Supernaturalitate," meaning "not confirmed as supernatural" (still under investigation), and emphasized that the judgment of the apparition remains solely at the discretion of the Congregation for the Doctrine of the Faith.

Despite Archbishop Victorinus Gong-Hee Yoon's persistent judgment, the Archdiocese of Gwangju has consistently condemned Naju as heresy. However, the Vatican has repeatedly ignored these attempts. The Vatican's official stance on Naju remains as stated

in a letter sent by the Prefect of the Congregation for the Doctrine of the Faith to Archbishop Hyginus Hee-Joong Kim in March 2011. These facts indicate that the Vatican has already accepted the manifestations of the Blessed Mother of Naju.

### The Truth about the Obedience

- Regarding the insistence that "Hardly obey the command from Diocesan bishop"
- ▶ Julia's endeavor to obey the Declaration issued by Gwangju Archdiocese :

After the announcement of the first Declaration, Julia lived in hiding in her attic for 7 years, and was fulfilling her Sunday obligations as well as earnestly paying the denarius cultus in the church. The prayer meeting in Naju was autonomously kept going by pilgrims to Naju.

- ▶ After Archbishop Andrew Choi was appointed as Diocesan bishop, Fr. Luke Hong-Chul Song, Pastor of Naju Parish Church, set the following preconditions for Julia in June 2001:
- ① Returning the statue of the Blessed Mother shedding tears (Actually Return is incorrect term because it is orginally belonging to Julia not, diocese)
- ② Closing the Blessed Mother's House and the Blessed Mother's Mountain
- ③ "Come to the 10 o'clock Mass this Sunday. I will give Julia and Julio the microphone. If you confess to the congregation that you have been fabricating everything and lying for the past 15 years and ask for forgiveness, I will receive you back into the Church."
- ▶ Julia said she could comply with conditions 1 and 2, but regarding condition 3, would it be right to betray the Lord and the Blessed Mother by admitting to falsehoods just to go to church?

# The Vatican's favorable stance regarding Naju

### St. Pope John Paul II

After examining the report on Naju by the Apostolic Nuncio to Korea, the Holy Father dispatched Msgr. Vincent Thu, one of his private secretaries, to Naju on September 18, 1995 and sent his message to Mrs. Julia Kim: "I extremely love and respect the Blessed Mother

of Naju and also highly love and respect Julia who offers up sufferings and delivers the Message of Love."

Through Msgr. Thu, Julia was invited to attend Mass in the Holy Father's private chapel in the Vatican. During the Mass celebrated by the Holy Father on October 31, 1995, the Eucharist that Julia received became larger



and turned into alive and moving Flesh and Blood on her tongue. The Holy Father was very surprised when he saw the changes in the Eucharistic species. He gave a blessing to Julia and made a cross on her forehead with his hand and also gave blessing for her family in Korea.



On Oct 31, 1995, The Holy Father witnessed the Sacred Host turned into live Flesh and Blood on Julia's tongue, gave a blessing to her.

During the Korean Bishops' ad limina visit in 1996, Pope John Paul II advised the Bishops, "Share the wonderful grace in Naju with other countries in Asia" The Holy Father also separately met Bishop William McNaughton of the Incheon Diocese in Korea to receive more information about Naju and said to the Bishop: "I also saw the change in the Eucharist in Julia's mouth."



□ In the church at St. Michael's shrine in Italy, the photographs of the Eucharistic Miracle on Oct 31, 1995 were displayed to the public along with other Eucharistic Miracles in Lanciano, Siena, Orvieto, and so on, all already officially recognized by the

Church, which was an indication that the miracle through Julia in the Vatican was being presented to the public as one of the miracles recognized by the Church. The printed explanation in Italian

on the wall said, "The Holy Father not only witnessed the Eucharistic miracle through Julia Kim on October 31, 1995 but he was one of the main participants in the supernatural phenomenon."

In addition, the Holy See also granted permission to a major Catholic TV station in Italy to air the information about the Eucharistic Miracle in the Vatican and broadcast more general information about Naju all over Italy. It was understood that these public displays that involved the Holy Father himself must have been possible only with the Holy See's permission.



# Healed of colon cancer by answering "Amen"



After incurring debts up to 300 million Won, my husband ran away from home and even left his children behind in 1998, My sorrow intensified when I was diagnosed with three malignant tumors: two 3cm and one 2cm in my colon and mesoileum at

Jeon-nam and Seoul National University Hospital. I prepared myself for death and sustained my frail life by taking painkillers. Meanwhile, I came to Naju to pray and listened to Julia who reminded me of all my wrongdoing in my past life like recorded film.
